A motion was made by Casavant and seconded by Burkhart to approve the Title Consolidated Application for 2021-2022 school year, naming Sue Kranz as the head of Title I, Foster Care, Homeless director, and Christopher Bachmeier the head of Title IIA and Title IV Director. Motion carried.
